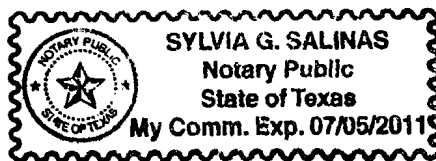

STATUTORY DURABLE POWER OF ATTORNEY

NOTICE: IN ACCORANCE WITH CHAPTER XII, TEXAS PROBATE CODE.

I, Cirino Gonzalez 1121 Gresham Alice, TX. 78332, appoint Jose M. Gonzalez 1025 N. Wright Alice, TX. 78332 as my agent (attorney-in-fact) to act for me in any lawful way with respect to all of the following powers except for a power that I have crossed out below.

Real property transactions;

Stock and bond transactions;

Commodity and option transactions;

Banking and other financial institution transactions;

Business operating transactions;

Insurance and annuity transactions;

Estate, trust, and other beneficiary transactions;

Claims and litigation;

Personal and family maintenance;

Benefits from social security, Medicare, Medicaid, or other governmental programs or civil or military service;

Retirement plan transactions;

Tax matters.

IF NO POWER LISTED ABOVE IS CROSSED OUT, THIS DOCUMENT SHALL BE CONSTRUED AND INTERPRETED AS A GENERAL POWER OF ATTORNEY AND MY AGENT (ATTORNEY IN FACT) SHALL HAVE THE POWER AND AUTHORITY TO PERFORM OR UNDERTAKE ANY ACTION I COULD PERFORM OR UNDERTAKE IF I WERE PERSONALLY PRESENT.

SPECIAL INSTRUCTIONS:

ON THE FOLLOWING LINES YOU MAY GIVE SPECIAL INSTRUCTIONS LIMITING OR EXTENDING THE POWERS GRANTED TO YOUR AGENT.

Agent responsibility applies to applications of duties only and excludes legal or civil responsibility for previous or future inaction on the part of all parties involved.

SHOULD I BECOME UNABLE TO REVOKE THIS POWER OF ATTORNEY FOR ANY REASONS LISTED OR UNLISTED, MY AGENT WILL CONTINUE ASSUMING THIS POWER OF ATTORNEY FOR THE REMAINDER OF MY NATURAL LIFE OR UNTIL MY AGENT OTHERWISE MAKES ARRANGEMENTS.

I shall be considered disabled or incapacitated for purposes of this power of attorney if a physician certifies in writing at a date later than the date this power of attorney is executed that, based on the physician's medical examination of me, I am mentally incapable of managing my financial affairs. I authorize the physician who examines me for this purpose to disclose my physical or mental condition to another person for purposes of this power of attorney. A third party who accepts this power of attorney is fully protected from any action taken under this power of attorney that is based on the determination made by a physician of my disability or incapacity.

I agree that any third party who receives a copy of this document may act under it. Revocation of the durable power of attorney is not effective as to a third party until the third party receives actual notice of the revocation. I agree to indemnify the third party for any claims that arise against the third party because of reliance on this power of attorney.

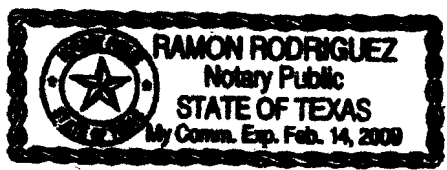
